Whereas, "Borrower", desires to **BORROW** a Rally Comp Race Compliance Meter, Iridium Tracking Unit, GPS Antenna, Buzzer and Cables (hereinafter called "RCItems") for use in the **EVENT**.

****A Fee up to \$1,000.00 will be charged if the Rally Comp is damaged, destroyed or not returned. **Other damages TBD **A processing fee of 2.2500% will be added to your card "IF" the card is used.**

Borrower understands that the RCItems are being **LOANED** for timing and scoring of the **EVENT** and are a requirement for participation in The Event.

Borrower understands that the RCItems **MUST BE RETURNED** to Rally Comp officials prior to leaving The Event and upon completion of the Event or upon early withdrawal. Borrower will not be scored as completing The Event until the RCItems are returned. If the Rally Comp Unit is not returned the Borrower may be asked for monetary compensation of up to \$1,000 for the RCItems. Borrower is responsible for any shipping incurred in returning the RCItems.

Borrower understands that the RCItems contain **PROPRIETARY TECHNOLOGY** and the Rally Comp unit is not to be opened by the Borrower and may not be used for any purpose other than scoring The Event. Borrower understands that if the RCItems are used by the borrower for purposes such as Reverse Engineering the Borrower may be liable for additional damages.

This guaranty is, and shall be deemed to be, a contract entered into under the pursuant to the laws of the state of Texas and shall be in all respects governed, construed, applied and enforced in accordance with the laws of said State, and no defense given or allowed by the laws of any other state of the United States of America shall be interposed in any action hereon.
